Medical School in Worcester. He also recently completed a fellowship in neuropsychiatry at UMass Medical School.

Dr. Freeman succeeds Dr. Steven Spitz, who has retired from Harbor Counseling after nearly 30 years of service at Lifeworks. “We are extremely grateful to Dr. Spitz for his dedication to our organization and the care he has provided to the Harbor Counseling community through the years,” Blanchard said.
